I applied for IPO of LAWSIKHO, through their Portal, for 4000 Shares at Rs.140/- each. The Shares were allotted to me. Besides this, there had been regular daily trading of Stocks and I could mobilse Rs.5,60,000/- , only after investing Rs.2 Lakhs initially. We were advised noto withdraw the money for 30 days from date of listing, as per their agreement with the IPO Company, assuring 150% of return. Unfortunately, beofore the deadline of 30 days, the portal was closed and the whatsapp group becmae silent and inactive. I tride to contact them using the mobile number given in the whtasapp group, but in vein. There was no response for personal whatsapp messages also. I am
