Subject: Update under Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 in respect of criminal proceeding initiated by Addictive Learning Technology Limited (the “Company”)

Dear Sir/Madam,

In compliance with Regulation 30 and other applicable provisions of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended, we wish to inform you that a First Information Report (FIR) has been registered by the Kalighat Police Station in Kolkata upon complaint by the Company against certain ex-employees.

The Material Litigation and Material Creditors Policy of the Company requires disclosure of all criminal proceedings (irrespective of the amount of impact) and hence the Company is reporting the same upon initiation of the proceeding i.e. the registration of the FIR.

The brief particulars of the litigation as required under Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, read with SEBI Circular No. SEBI/HO/CFD/PoD2/CIR/P/0155 dated 11 November 2024 are as follows:

Maheshwari and Mr. S. Singh and others with the Kalighat Police Station at Kolkata on 24th April, 2025 regarding forgery, misappropriation, criminal breach of trust, copyright infringement and data theft. The FIR for the same was registered by the Police Station and the registration was communicated to the Company on the night of 7th May, 2025.
